#### WELCOME AND CALL TO ORDER Mayor Phil Fisher

#### INVOCATION AND PLEDGE OF ALLEGIANCE TO THE FLAG

The invocation was led by Alderman Barnett followed by the pledge of allegiance to the flag led by Alderman Cronin.

#### RECOGNITIONS

The Mayor read two letters from citizens. The first letter was from Bill Broadus complementing the Sewer Department for work they performed on a sewer problem. The second letter was from Bobby Hall complimenting the Parks and Recreation Department for the addition of exercise machines and other equipment at the Wood Activity Center.

#### PUBLIC HEARING

A Public Hearing was held to discuss the laying out and construction of a public sewer system in the Southern Oaks Subdivision. Sammy Asemota of 404 Windsor Drive had two questions. The first question was whether the City was responsible for financing the project and the second question was who would own the project when completed. The Mayor informed Mr. Asemota that based on the past all other projects of this kind were financed by the persons that would gain the benefit and that the City would own and maintain the system once it was completed. Larry Ezell, President of the Homeowners Association read a statement from the association that supported the project and asked that the board approve the project as soon as possible. The statement is made a part of these minutes. James W. Nobles, Jr was unable to attend the Public Hearing; however he submitted a written statement against the project. His written statement is made a part of these minutes. No other comments from the citizens of the Southern Oaks Subdivision was received or made. The Mayor then closed the Public Hearing.

Upon presentation by Phil Fisher, Mayor, <u>MOTION</u> was made by Alderwoman Cossitt and <u>SECONDED</u> by Alderman Brabham to approve a resolution finding lack of objection or protest sufficient to preclude the municipality from proceeding with the construction of a sanitary sewer system and the assessment of the cost of such sewer system against the property benefitted and for related purposes for the Southern Oaks Sewer System. <u>MOTION</u> CARRIED UNANIMOUSLY

#### **DEPARTMENT HEAD REPORTS**

Mike Warren, Police Chief reported to the board the statistics for calls for service, traffic stops, number of tickets written, and number of arrests for the period February 24, 2014 through March 9, 2014 as compared to the same period in 2013. He also informed the board that he had met with the organizers of the Will Graham weekend to discuss the traffic and parking plan for the event. He also informed the board that he had hired one new police officer.

Barry Burnside, Fire Chief reported the statistics on the number of service calls including medical and fire calls for the period January 1, 2014 through March 17, 2014 as compared to the same period in 2013. He also updated the board on various activities and programs the fire department was involved in. These activities and programs included a visit from students from the Magnolia Speech School, a meeting with various agencies that would be involved with the Will Graham weekend, that his department would assist with the Mud Heights event to be held the coming weekend, and that four fighter positions were recently posted and that he was anticipating the hiring process to be completed by June 2014.

Mike Parker, Director of Public Works reminded the board of the upcoming City Wide Cleanup event to be held March 29, 2014 through April 5, 2014, that someone had run into the City sign on Northside Drive and he was in the process of repairing the damage, and he updated the board on the sewer backup problem on Beverly Drive.
