APPROVE A MOTION TO AUTHORIZE THE WAIVER OF CERTAIN AND VARIOUS COSTS ASSOCIATED WITH THE CITY'S MAINTENANCE OF PARCEL 2860-836-520, FOR THE PURPOSE OF RESOLVING AND SETTLING A DISPUTED CLAIM ASSERTED BY Y & C DESIGN AND CONSTRUCTION, LLC, AN ENTITY THAT FILED SUIT AGAINST NUMEROUS DEFENDANTS FOR THE PURPOSE OF CLEARING TITLE TO THE PARCEL, WHICH PARCEL WAS PREVIOUSLY FORFEITED TO THE STATE BY TAX SALE AND RETURNED TO Y & C DESIGN AND CONSTRUCTION, LLC, BY FORFEITED TAX LAND PATENT, WITH A FINDING BY THE CITY THAT CLEARING THE TITLE WILL BENEFIT THE CITY BY RETURNING THE PARCEL TO THE TAX ROLLS

Upon presentation by Chelsea Brannon, City Attorney, MOTION made by Alderman Cashion and SECONDED by Alderman Ellis the board approved a motion to authorize the waiver of certain and various costs associated with the City's maintenance of parcel 2860-836-520, for the purpose of resolving and settling a disputed claim asserted by Y & C Design and Construction, LLC, an entity that filed suit against numerous defendants for the purpose of clearing title to the parcel, which parcel was previously forfeited to the state by tax sale and returned to Y & C Design and Construction, LLC, by Forfeited Tax Land Patent, with a finding by the city that clearing the title will benefit the city by returning the parcel to the tax rolls.
