Clinton Youth Associations Sponsorship Agreement

This agreement, made as of this the _____ day of _____ (“Effective Date”), is entered into between the City of Clinton (“the City”) and _____ (“Sponsor”), to support the development, construction, operation and maintenance of the Clinton Youth Sports Complex for the designated sport (**CIRCLE ONE: Baseball, Softball, Soccer**), located at Traceway Park in Clinton, Hinds County, Mississippi:

1. *Purpose of Agreement.* The purpose of this Agreement is to describe the sponsorship activities and the level of financial support to be provided to the City by the Sponsor for the development, construction, operation, and maintenance of above designated sport association, and to contractually bind the parties to the same terms herein.

2. *Sponsorship levels, term and fees.* In consideration of the benefits afforded the Sponsor herein, the Sponsor agrees to financially support the Clinton Youth Sports Association designated above, on the terms as indicated below (**CHECK ONE**):

_____ Team Sponsorship - \$350 yearly
Sponsor is entitled to the benefits of having their name displayed on the team uniforms.

_____ Banner Sponsorship
Sponsor is entitled to the benefits of having their name displayed on a banner at the sports complex for the above designated Clinton Youth Sport.

_____ \$500 – Sponsorship rights for a one (1) year term.
Payment terms are \$500 per year for one (1) year.

_____ \$1,350 – Sponsorship rights for a three (3) year term.
Payment terms are \$450 per year for three (3) years.

_____ Field Sponsorship
Sponsor is entitled to the benefits of having their name displayed on a field at the sports complex for the above designated Clinton Youth Sport.

_____ \$4,500 – Sponsorship rights for a three (3) year term.
Payment terms are \$1,500 per year for three (3) years.

_____ \$6,500 – Sponsorship rights for a five (5) year term.
Payment terms are \$1,300 per year for five (5) years.

_____ \$10,500 – Sponsorship rights for a ten (10) year term.
Payment terms are \$1,050 per year for ten (10) years.

_____ Scoreboard Sponsorship

Sponsor is entitled to the benefits of having their name displayed on a field scoreboard at the sports complex for the above designated Clinton Youth Sport.

\$3,000 – Sponsorship rights for a three (3) year term.

Payment terms are \$1,000 per year for three (3) years.

3. *Sponsorship Consideration/Terms of Payment.* The consideration due from the Sponsor shall be in the amount designated by level of sponsorship chosen above. Checks should be made payable to the respective association.
4. *Covenants of the City.* Funds received from the Sponsor pursuant to this Agreement shall be expended for: (a) the construction, operation, and/or maintenance of the Clinton Youth Sports Associations at the discretion of THE CITY; or (b) sponsorship of a specific aspect of the Clinton Youth Sports Associations as specified below:

5. *Force Majeure.* THE CITY shall not be responsible to the Sponsor for failure to perform any of the obligations imposed by this Agreement is such failure is occasioned by fire, flood, explosion, lightning, windstorm, earthquake, or other natural disaster that is beyond the reasonable control of THE CITY.
6. *Governmental Approval.* THE CITY obligations hereunder shall be conditioned upon the governing body of the City adopting resolutions, authorizing the City to purchase, fund and finance adequate and necessary resources to develop, construct, and operate the Clinton Youth Sports Associations.
7. *Assignment.* This Agreement shall be binding upon the successors of the Sponsor, and shall not be assignable by either party without prior written consent of both parties.
8. *Governing Law.* The validity and interpretation of this Agreement shall be governed by Mississippi law.
9. *Entire Agreement.* This Agreement embodies the entire understanding between the parties, with respect to the sponsorship contemplated herein and supersedes any prior or contemporaneous agreements, either written or oral. No amendments or changes to this Agreement shall be effective unless made in writing and signed by the authorized representatives of all parties.
